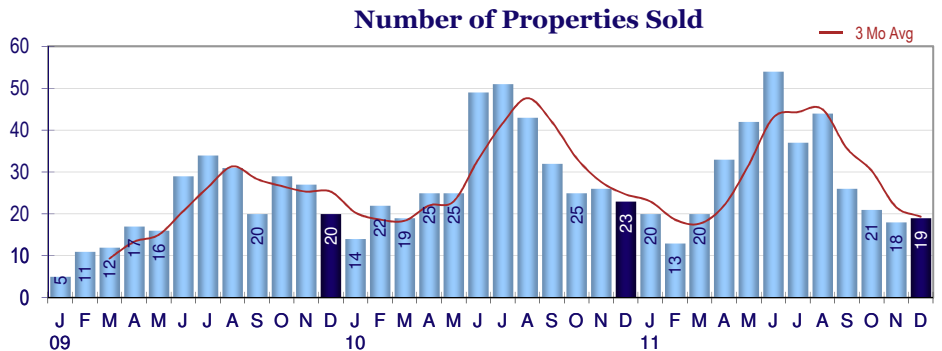

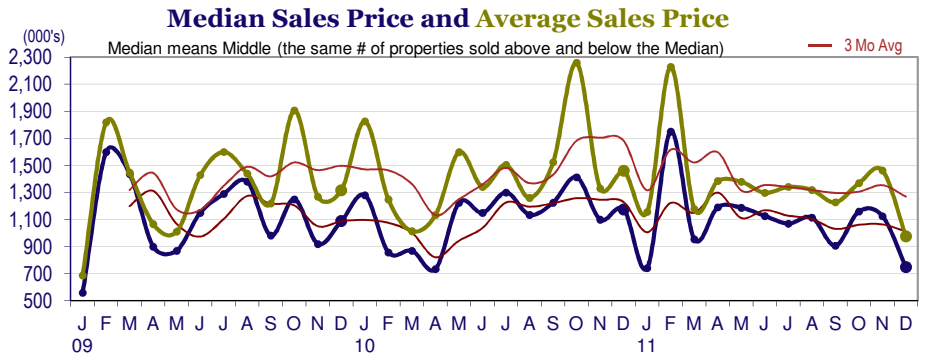
## Property Sales

December Property sales were 19, down 17.4% from 23 in December of 2010 and 5.6% higher than the 18 sales last month. December 2011 sales were at their lowest level compared to December of 2010 and 2009. December YTD sales of 347 are running 2.0% behind last year's year-to-date sales of 354.



## Prices

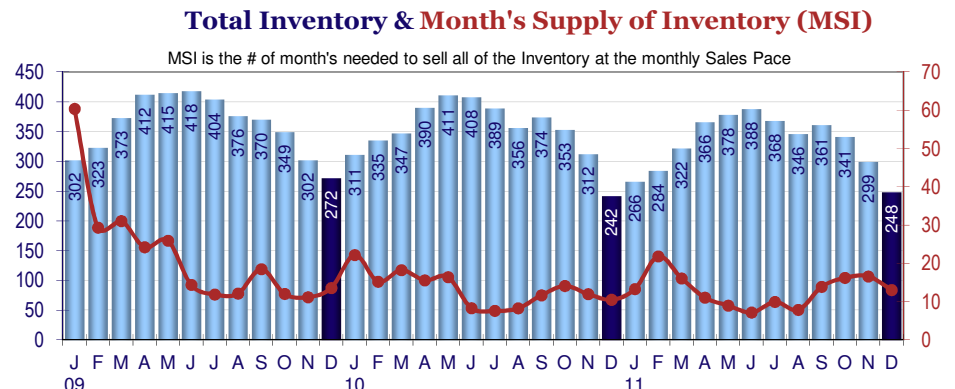
The Median Sales Price in December was \$750,000, down 36.2% from \$1,175,000 in December of 2010 and down 33.3% from \$1,125,000 last month. The Average Sales Price in December was \$976,607, down 33.1% from \$1,460,352 in December of 2010 and down 33.3% from \$1,463,333 last month. December 2011 ASP was at the lowest level compared to December of 2010 and 2009.



## Inventory & MSI

The Total Inventory of Properties available for sale as of December was 248, down 17.1% from 299 last month and up 2.5% from 242 in December of last year. December 2011 Inventory was at a mid level compared with December of 2010 and 2009.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The December 2011 MSI of 13.1 months was at a mid level compared with December of 2010 and 2009.

## Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for December was 124, up 24.0% from 100 days last month and up 29.2% from 96 days in December of last year. The December 2011 DOM was at a mid level compared with December of 2010 and 2009.

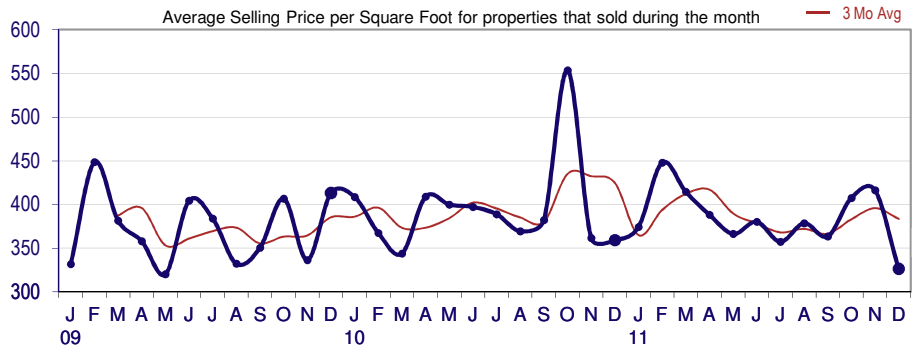
## Days On Market for Sold Properties



## Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The December 2011 Selling Price per Square Foot of \$327 was down 21.6% from \$416 last month and down 9.1% from 359 in December of last year.

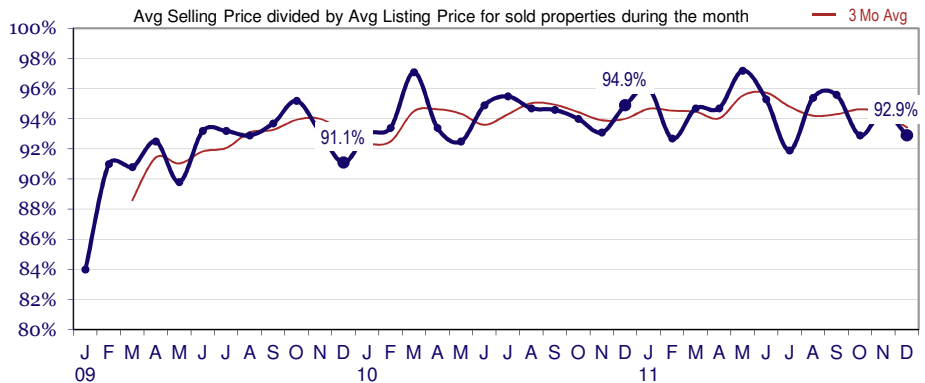
## Selling Price per Square Foot



## Selling Price vs Original Listing Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The December 2011 Selling Price vs Original List Price of 92.9% was down from 94.5% last month and down from 94.9% in December of last year.

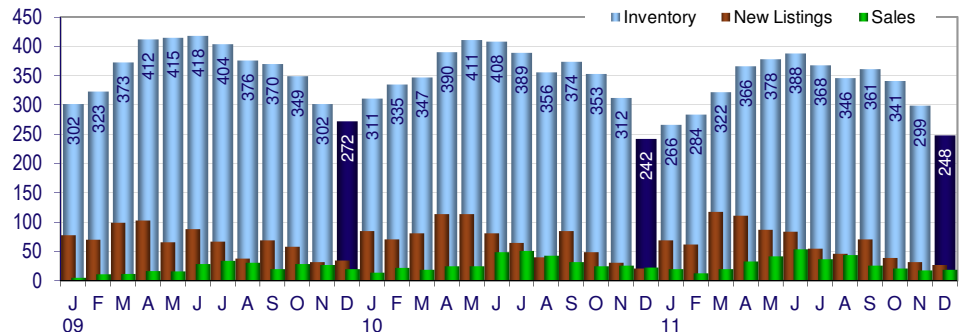
## Selling Price versus Listing Price Ratio
